The 2010-2011 LWVB/N year has been very productive. We sponsored a series of programs on topics of interest to our community. We started with "Ethics In Government" in September. October was reserved for election related activities including our "Voter Guide, paper and Online Editions."

In November we held a forum on "Redistricting". This program featured a Power Point presentation which is still available on our website. (www.lwvbn.org). December was fund-raising month – our League members were at the Eastern Hills Mall to wrap gifts throughout the holiday season. In January we had our forum on "The Role of the Federal Government in Public Education." This forum was also broadcast on the radio and the slide show is still available on our website. In March our Natural Resources Committee sponsored a showing of "Gasland", the Academy Award nominated documentary on drilling for natural gas and "fracking" shown at the Palace Theatre in Hamburg.

We continue to welcome new citizens each month at the naturalization ceremonies in Buffalo and sponsor and moderate candidate forums for the school board elections for many local school board elections. We are already planning candidate forums for the general election next fall and organizing our "Voter Guide" 2011 edition.

Our delegates attended the recent LWWNYS Convention in Albany. We will report what we learned and work to implement new programs and projects.

S. has monitored the Horn of Africa due to security concerns. Internal instability, weak governments in some countries, regional rivalries and a lack of development have resulted in an environment conducive to terrorism. Can the U. S. protect its national interests while mitigating the dangerous conditions in the region?" Can we even name the countries of the Horn? Come and be informed.

Marie Hanrahan and Joan Photiadis are trading months so our topic for Thursday July 7, 2011, led by Marie will be ***Germany's Ascendancy*** and as usual held from 10:00 a.m.-noon at 1272 Delaware. "Germany has emerged from both the financial crisis and the eurozone crisis as the dominant economic political power in Europe, in particular setting the tone for dealings with Russia, Eastern Europe and Iran. How important is it for U. S. interests to enhance relations with Germany, and how should the U. S. react when German and U. S. interests fail to align?"

On Thursday, August 4, 2011, Joan will lead the discussion on ***Banks***, governments and debt crisis at our same time, same place. "As an immediate response to the financial crisis of 2007-08 governments around the world stepped in to bail out troubled private banks deemed "too big to fail" underscoring the interdependence between private and public finances. "How will the proposed Buffalo Harbor Bridge Impact our Waterfront's Future?"

Meet us at 10:00 a.m. at the Hatch on the Waterfront.



We'll stroll the promenade to Canal Side and end at the foot of Main Street in Buffalo, noting the alternative sites for the proposed Buffalo Harbor Bridge.

Our purpose is to see first-hand the possible sites for the Buffalo Harbor Bridge, as a basis for making informed assessments about the proposed Buffalo Harbor Bridge and evaluating its impact on Buffalo's waterfront.

Note that the walking distance from the Hatch to the Main Street site is about a half mile.

Redistricting Update

Redistricting - the redrawing of legislative district boundaries - occurs on all levels of government. Local redistricting has moved forward quickly this spring to be completed in time for the 2011 elections. At this mid-May writing, the Buffalo Commission has approved a plan to be submitted to the public for comment. The Niagara County's plan, that also includes downsizing from 19 to 15 legislators, has been approved by its legislature. The Erie County Commissioners struggle to come to consensus on a plan to present to the public for comment.

League members have attended all local Citizen Advisory Commission work sessions, meetings and hearings. Our comments at the first public hearing in Erie County have been posted on the league website, www.lwvbn.org for members and the public to read.

New York State redistricting reform has not yet been achieved. We continue to lobby for important reforms that will lessen the influence of partisan politics in redistricting. Janet Goodsell is working with League members to ask our state legislators to support and commit to the reform measures we endorse.

There is a place for every League member to be active on redistricting. Give us a call. If you have an email address let us know. You will be able to respond quickly by having the most up to date information.
