Nuclear Scrabble: Some Government Agencies at West Valley

A public citizen trying to engage at the West Valley Demonstration Project (WVDP) is immediately exposed to an alphabet soup of acronyms for the many government agencies and private contractors involved there. Our March 12 speaker Elizabeth Lowes, for example, has worked for NYSERDA and DOE and now works for CH2M HILL BWXT West Valley. Got that? Because she is trained in industrial hygiene and environmental toxicology, in all three cases her niche is the environmental regulation framework.

CH2M HILL BWXT West Valley, known on their website as www.chbwv.com, is the company that has been the prime contractor at the site doing the demolition and other decommissioning work since 2011. They are kin to another CH2M offshoot at Hanford, the big nuclear project in Washington State that provided much of West Valley's used atomic reactor fuel for reprocessing in the 1960s. What does CH2 stand for? Very few people know (or need to know) that, but according to Wikipedia they are the three civil engineers from Oregon State University who founded the company in 1947, Cornell, Howland, and Hayes. Repeated mergers and the formation of subsidiaries have followed, as is typical of the industry.

DOE is the U.S. government's Department of Energy. It was created in 1977 as a cabinet-level agency combining research and development of energy technology, energy conservation, and the nuclear weapons program. Within the DOE, the Office of Environmental Management oversees the West Valley Demonstration Project, along with 15 other big environmental remediation projects resulting from nuclear bomb manufacture and nuclear research.

The old Atomic Energy Commission (AEC) was split into the DOE and the NRC (Nuclear Regulatory Commission), which continues to regulate nuclear reactor safety and radiation protection. In 2021-22, for example, the NRC's big job at West Valley is approving the plan for regulating air pollution from the demolition of the Main Process Plant Building.

NYSERDA is the New York State Energy Research and Development Authority. Alas, unlike the two above, they will be there for a long time because they (or should I say "we," New York State) are the owners of the site. They also have primary responsibility for the State Disposal Area and the part of the West Valley site outside the 150 acres of the West Valley Demonstration Project. On an unused part of the larger site, NYSERDA has recently developed a large installation of solar panels to benefit local electricity consumers.

Even after you figure out the players it can be hard to understand the game. For example, the New York

Department of Environmental Conservation (DEC) is concerned about the "forever chemicals" at the West Valley site and has regular interactions there. But I was surprised to discover that the forever chemicals they are concerned with are only the hydrocarbons. The radioactive chemical isotopes that will last for millions of years are outside their purview.

So, who is looking out for our air, water, and health at this nuclear site upstream from us? Well, it depends: different agencies, different toxics, different media (air, water, soil). It takes many specialists. It also takes many dedicated non-specialists (like League members!) to interpret the specialist knowledge to other members of public, who have multiple stakes in what happens there, as residents of affected communities, taxpayers funding the cleanup, and ancestors of generations that will be exposed to the outcome of remediation. Let's strive to be good ancestors!
