# **Naturalization Ceremonies**

Thanks to 16 League members who volunteered for naturalization ceremonies from January through December 2024. In concert with our partners at the Erie County Board of Elections we greeted 745 new citizens and successfully registered 692 on the day of their naturalization. The other new citizens chose to take their forms home and talk to their families before they filed their forms. Citizens were welcomed to the U.S. from many countries including Afghanistan, Bangladesh, Bosnia and Herzegovina, Brazil, Burma, Canada, China, Congo, Cuba, Dominican Republic, Eritrea, Ghana, Guyana, Haiti, India, Iraq, Jamaica, Jordan, Lebanon, Liberia, Mexico, Mongolia, Morocco, Nepal, Netherlands, Nigeria, Pakistan, Peru, Philippines, Russia, South Korea, Spain, Sri Lanka, Sudan, Syria, Thailand, Turkey, Ukraine, United Kingdom and Vietnam.

# **Voter Identification (ID) Considerations**

When I voted in November 2024, I heard many people asking whether they needed ID to cast their ballot. In fact, voting in New York State does not require IDs. As has been the practice for many years, at your local voting site, poll workers compare the signatures of New Yorkers to verify their identities. It's that simple.

In contrast, federal law requires a valid form of ID – such as a driver's license or Social Security number – to register to vote. This has been required since 2002 when Congress passed the Help America Vote Act.

Voting rights and accessibility advocates who back free and robust elections argue that mandating IDs at the polls would block eligible citizens from participating in democracy.

Photo ID laws deprive many voters of their right to vote, reduce participation, and are antithetical to the goal of including more Americans in the democratic process. Many Americans do not have one of the forms of government-issued photo identification that some state laws list as acceptable for voting. These voters are disproportionately low-income, racial and ethnic minorities, the elderly, and people with disabilities. Such voters more frequently cannot afford or cannot obtain the underlying documents that are a prerequisite to obtaining a government-issued photo ID card.

Senate and Assembly Republicans in New York repeatedly proposed legislation requiring voter ID in the last legislative session. And given that Republicans will occupy the White House and will be the majority in both the U.S. House of Representatives and the U.S. Senate in 2025, there's a good chance they will propose a federal law that requires government-issued photo ID in order to cast your ballot.

# **Great Decisions**

The League-sponsored Great Decisions discussion group is assessing continuing in 2025, dependent on sufficient interest. The group meets from March through October and each month discusses a chapter from the Foreign Policy Association's Great Decisions booklet. The books are available at the FPA website (https://www.fpa.org/great\_decisions) and cost \$35 plus shipping, handling and tax. We meet at 10:00 a.m. on the first Thursday of the month, via Zoom, for approximately two hours. The topics for 2025 are listed below and are always relevant to world events. Consider joining for some or all of the sessions.

#### **Great Decisions 2025 Topics**

**American Foreign Policy at a Crossroads**, G. John Ikenberry. *This chapter will explore the contours of the U.S. foreign policy debate as it plays out in a world of multiple and escalating crises and domestic polarization.* 

**U.S. Changing Leadership of the World Economy**, Daniel Drezner. *Under President Biden, the U.S. has advanced new ideas about trade, technology, industrial policy, competition with China, and the organization of the world economy. For most of the post-war era, the U.S. has tied its global leadership to cooperative agendas aimed at creating a more open world trading system, but that has apparently come to an end. What are America's options and opportunities as a leader of the world economy? How will America's "foreign policy for the middle class" and strategic competition with China impact its leadership role? How can the post-war rules and institutions of the world economy be made safe for economic nationalism and great power competition?* 

**U.S.-China Relations**, Thomas J. Christensen. *Washington's relations with Beijing have reached an ominous low ebb. Both American political parties have identified China as the country's preeminent geopolitical challenger and, in the eyes of many, a systemic threat. What is driving this deterioration of Sino-American relations, and what are America's strategic options in the face of Chinese power and ambition?* 

India: Between China, the West, and the Global South, Leslie Vinjamuri. India is an emerging major power in world affairs, occupying a pivotal position between China, the United States, and the Global South. Its population size, economy, and geopolitical location ensure that it will be an influential voice in debates and political struggles over global order. What are India's choices and opportunities for regional and global leadership? How will it maneuver between China and the United States, and what is its role as a voice of the Global South? What opportunities exist for Washington to work with India?

International Cooperation on Climate Change, Josh Busby. The 2015 Paris Agreement established a UN-sponsored framework for negotiations on climate change and global warming. In subsequent COP meetings, experts and political leaders have come together seeking common cause for this growing global crisis. What is the future of these efforts, and what have they yielded? What is the U.S. role in fostering cooperation on climate change? In a divided country, what are the possible futures for American policy leadership?

The Future of NATO and European Security, Kori Schake. European security is more uncertain than it has been for decades. Putin's Russia has launched a war with Ukraine on its doorstep, and America's uncertain role as leader of NATO and security provider has been called into question with the failure of Congress to pass supplemental military support for Ukraine. What are Europe's options, and how might developments on both sides of Western Europe – in Ukraine and across the Atlantic – impact its choices? What are America's stakes in NATO and Europe's strategic dilemmas?

Al and American National Security, Julie George. The AI revolution is the leading edge of a larger high-tech revolution, which promises to transform the world. Experts argue that international cooperation is needed to expand the opportunities these new technologies hold while protecting societies from their dangers. What are the key policy debates in this area, and what are the opportunities and limits on global AI rules of the road? How will the AI revolution impact American national security? What are its policy options to secure the benefits of AI and guard against its dangers?

American Foreign Policy in the Middle East: Taking Stock and Looking Ahead, Daniel Kurtzer. The war in Gaza has brought the region to a crossroads. What are the possible outcomes of the war, and how might the

United States use its influence to shape a long-term settlement that leaves both Israel and the Palestinians in a better position? How might Arab states in the wider region be brought into a settlement? What are America's interests in the Middle East and how can it advance them?

# 2024-2025 Federal Judiciary Study

At the 2024 LWVUS convention, the delegates voted to proceed with a one-year Study of the Federal Judiciary. The scope of the study is to develop a League of Women Voters position on the federal judiciary as an essential component of U.S. democracy. The study purposes address concerns and clarification of judicial accountability, transparency, independence and ethics. It addresses the Supreme Court as well as other Article III federal courts.

Our League is participating in this study and will hold a consensus meeting in late March or early April. In addition, we may have some discussion opportunities when the resources have been published on the LWVUS Management site. You may want to check out the current resources. To access the study materials, go to www. lwv.org, scroll down the page to LEAGUE MANAGEMENT and click on it. In the menu on the top right side of the new page click on Content Library. Enter Judicial study in the search box and click on go. Scroll down the topics list and you'll reach "2024-2025 Federal Judiciary Study Process, Committee, and Resources." (I bookmarked that so I don't need to go through the whole search process again.)

You may want to view the recording of the Kickoff Webinar from November 20, 2024. I found it quite helpful. The committee chair gave a clear explanation about the goals of the study. LWVUS will also host a National Town Hall on the Federal Judiciary in January, TBA. There are several resources posted already.
